

IBERIABANK Corporation Increases Cash Dividend

The Board of Directors of IBERIABANK Corporation, announces the declaration of a quarterly cash dividend of \$0.32 per share, up 23% compared to the same quarter last year and 7% compared to the second quarter of 2006. The dividend is payable on October 20, 2006 to shareholders of record as of September 29, 2006. This dividend level equates to an annualized dividend rate of \$1.28 per share. Based on the closing stock price on September 18, 2006, of \$63.63 per share, the indicated dividend yield is 2.01%.

Daryl G. Byrd, President and Chief Executive Officer of IBERIABANK Corporation commented, "We are very pleased to present this significant dividend increase to our shareholders. Over the past four years, our quarterly cash dividend has increased 100%."

At June 30, 2006, IBERIABANK Corporation had total assets of \$3.0 billion, shareholders' equity of \$266 million and a Tier 1 Leverage capital ratio of 7.46%. The Company's common stock trades on the NASDAQ Stock Market under the symbol "IBKC".

IBERIABANK Corporation shareholders may take advantage of the Company's Dividend Reinvestment Plan. This program provides a convenient, economical way for shareholders to increase their holdings of the Company's common stock. The shareholder pays no brokerage commissions or service charges while participating in the plan.

To enroll in IBERIABANK Corporation's Dividend Reinvestment Plan, shareholders must have their stock certificate numbers and complete an enrollment form. Enrollment forms and a summary of the plan are available from the Registrar and Transfer Company by calling (800) 368-5948.

IBERIABANK Corporation is one of the oldest financial institutions with continuous operations in the State of Louisiana and the second largest Louisiana-based bank holding company. The Company's market capitalization is approximately \$612 million.
