

## **IBERIABANK Corporation Increases Cash Dividend**

The Board of Directors of IBERIABANK Corporation, announced the declaration of a quarterly cash dividend of \$0.34 per share, up 13% compared to the same quarter last year, and up 6% compared to the first quarter of 2007. The dividend is payable on July 20, 2007 to shareholders of record as of June 29, 2007. This dividend level equates to an annualized dividend rate of \$1.36 per share. Based on the closing stock price on June 27, 2007 of \$49.87 per share, the indicated dividend yield is 2.73%.

Daryl G. Byrd, President and Chief Executive Officer of IBERIABANK Corporation commented, "We are pleased to provide our shareholders this increase in our quarterly cash dividend. Over the last five years, our quarterly cash dividend has increased at a compounded annual rate of nearly 19%."

At March 31, 2007, IBERIABANK Corporation had total assets of \$4.6 billion, shareholders' equity of \$472 million and a Tier 1 Leverage capital ratio of 7.80%. The Company's common stock trades on the NASDAQ Stock Market under the symbol "IBKC."

IBERIABANK Corporation shareholders may take advantage of the Company's Dividend Reinvestment Plan. This program provides a convenient, economical way for shareholders to increase their holdings of the Company's common stock. The shareholder pays no brokerage commissions or service charges while participating in the plan.

To enroll in IBERIABANK Corporation's Dividend Reinvestment Plan, shareholders must have their stock certificate numbers and complete an enrollment form. Enrollment forms and a summary of the plan are available from the Registrar and Transfer Company by calling (800) 368-5948.

IBERIABANK Corporation is a financial holding company based in Lafayette, Louisiana with offices serving an eight-state region. IBERIABANK Corporation and its predecessor organizations have served clients for 120 years. The Company's market capitalization is approximately \$640 million.
